2. Nominations are to be submitted in the prescribed form available at the office of the Returning Officer, Adv. P.C. Chacko, M.A., L.L.B, P.V.R. Associates, 61/714 Saradamadam Lane, Near Saradamadam, Ravipuram, M.G. Road, Ernakulam - 682 016.
3. Only the nominees representing the District Sports Associations affiliated with the concerned State Sports Associations recognized by Kerala Olympic Association are allowed to cast the vote as well as to submit the nomination.
4. The Electoral Roll shall be published in the website of Ernakulam District Olympic Association, Kerala Olympic Association, notice board of KOA, Office of Returning Officer
5. The Nomination of a candidate for election as office bearer or a member of Executive Council shall be proposed by one of the nominees whose name is included in the Electoral Roll and also subscribed by one such nominee as seconder.
6. No person shall be permitted to withdraw his/her name as proposer/seconder, once the nomination paper subscribed by him/her has been delivered to the Returning Officer.
7. A list of all nominations received within the stipulated time will be published, post wise, at the office of the Returning Officer or the place authorised by the Returning Officer.
8. No person shall be eligible to nominate more than one candidate for the same post, either as proposer or seconder.
9. Election by secret ballot will be adopted if the number of nominations received for any/each post is more than the approved number of any/each posts.
10. If the election is unopposed after finalising the list of contestants then the result can be announced on 30.08.2022 at 4pm.
